To the citizens of St. Tammany Parish and members of the Bar Association,

The next phase of Odyssey, WebROA, has been launched! With WebROA, you will have online access to more case information and will be able to track your filings through our office, including when they are sent to the judges for signature. In addition to WebROA, the status of daily Civil Filings & Processing is posted on our website, www.StTammanyClerk.org, in the blue 'Filing Dates' tab.

During the implementation phase, I decided to waive all online copy & subscription fees. With the new subscription plans, I am proud to say that we have eliminated the setup fees and for WebROA, have eliminated all online copy fees! Each online program has its own subscription plan and will require a separate login. Separate subscriptions provide you the flexibility to subscribe to only what fit your needs.

My goal with the new subscription programs is for the office to remain revenue-neutral. To achieve this, we plan to review the subscriptions after 3 months to ensure we are generating the same subscription revenue as we were prior to launching Odyssey. Subscription plan details, setup instructions, and WebROA User Guides are available on our website and in-person at our offices. In addition to these helpful guides, we will continue to host weekly training programs on WebROA and e-Filing. Please visit our website or follow our Facebook page for a schedule of training programs.

As always, I appreciate your patience and feedback as we continue to bring the office into the 21<sup>st</sup> century with technology and improve our processes to serve you more efficiently!
